• President's Report:

Discussed New York City's Education Department cuts of \$547 million. Cuts will affect free pre-k &3K programming, community schools that support families with out-of-school needs, and the Summer Rising program. A hiring freeze and slowdown will create a bulk of the savings and the elimination of 432 vacant non-classroom positions will lead to a combined \$157 million in savings. A mandate to rein in spending on "supplemental pay for administrative staff" is expected to save another \$86 million this year. New York City's teachers union is suing Mayor Eric Adamsto to halt school budget cuts. Adams is violating a state law barring the city from decreasing its contribution to schools when the city's overall revenue doesn't go down, the United Federation of Teachers' lawsuit argues. It is the second legal challenge from a municipal union in the last two weeks seeking to stop the cuts. DC 37, the city's largest public union, sued over the cuts last week.

District has selected HMH as our mandated Ela curriculum, and we'll begin phase 2 of that implementation in September of 2024.

District 75 schools, catering to students with complex disabilities, face significant budget cuts totaling around \$97 million. These cuts, ordered by Mayor Eric Adams, aim to achieve savings for the Education Department. Despite a rise in enrollment, these mid-year cuts are impacting extracurricular programs, supply budgets, and paraprofessional support for approximately 26,000 students. The

Vacant Councilmember Parliamentarian Department of Education attributes the cuts to the need to reconcile enrollment with resources and identify savings targets. Unlike other public schools, District 75 schools don't typically undergo mid-year adjustments, making these cuts particularly challenging for them.

The New York Class Size Working Group released a 55-page report with over 50 recommendations, including capping enrollment at overcrowded schools, relocating pre-K programs, and offering incentives for teacher hiring. The report is non-binding, and final decisions rest with Education Department officials. Mandates to limit class sizes are expected to be phased in over five years, with caps ranging from 20 to 25 students. While proponents cite research supporting smaller class sizes, Education Department leaders argue funding constraints. Concerns about enrollment restrictions and equity implications have also been raised. Some members of the working group dissented, issuing a minority report.

• Superintendent's Report:

Took a moment of silence to honor Rory DeCristoforo, a 6-year-old student from D 75 who lost her life in a house fire on New Year's Day. Celebrated the outpouring of love and support from the community.

Announced the retirement of Nancy Acosta Marillo and the appointment of Dr. Jason Codo as the new acting interim principal.

They highlighted positive developments at different schools, such as the supportive school Spirit Day gesture for a new principal at PS. 38 and the successful work at PS. 58 and PS. 20.

Addressed feedback from a Town Hall regarding bullying concerns, emphasizing efforts to support schools and students. The student services team is actively involved in educating parents on the distinction between bullying and conflict resolution, implementing restorative practices, and collaborating with Da Mcmahon's office to train parent coordinators in de-escalating bullying situations.
